Curriculum & Training

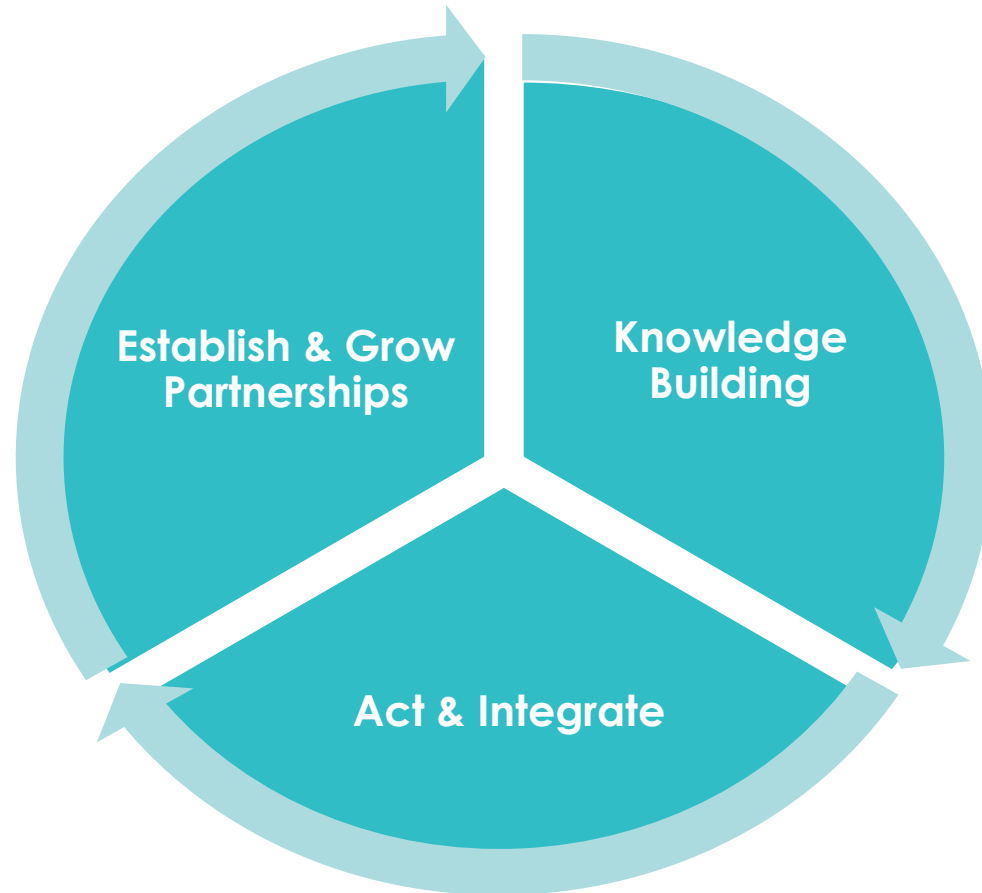

ACEs Aware Health Equity Updates

ACEs Aware Update: Health Equity Approach & Work Areas

Support and strengthen how health equity is embedded across all areas of the ACEs Aware initiative in message, definition, practice, and implementation, recognizing racial injustice and discrimination as risk factors for toxic stress.



Proposed Health Equity Statement

The ACEs Aware Initiative recognizes that ACEs are universal, and exposure to racial injustice and other forms of discrimination may place some communities at a higher risk for toxic stress. Increased risk may occur through differential distribution of ACEs, conditions that alter capacity for buffering, and direct activation of the toxic stress response.

As such, the goal of ACEs Aware is to augment provider capacity to understand and address the risk factors for toxic stress and the associated metabolic, immune and neuroendocrine responses. These efforts will support the broader Initiative goal to reduce the incidence of ACEs and toxic stress by half within one generation to ensure that all individuals can attain their full health potential.
