



ACES Aware Clinical Advisor

ACES Aware is a nation-leading initiative led by the Office of the California Surgeon General (CA-OSG) and the California Department of Health Care Services (DHCS) to give Medi-Cal providers training, clinical protocols, and payment for screening children and adults for ACEs.

Aurrera Health Group is the project management contractor for the ACEs Aware Initiative and will be the hiring manager for this position.

Job Description:

The ACEs Aware clinical advisor will be responsible for providing clinical expertise and support for the ACEs Aware initiative team as they execute various aspects of the program including:

- Advising CA-OSG and DHCS and Aurrera Health Group/ACES Aware team on statewide implementation of ACE screening and clinical response and other clinical aspects of the ACEs Aware initiative;
- Acts as a subject matter expert in the health implications of ACEs and toxic stress for the ACEs Aware initiative;
- Developing materials to support Medi-Cal providers in implementing ACE screening and response in their clinical practice, including clinical tools and an operational guide;
- Supports the ACEs Aware team by reviewing and advising on the scientific vetting, evidence base and references for scientific information in initiative materials and work products;
- Advising on provider engagement activities, including how to develop webinars and video content on topics and speakers of interest to implementing clinicians;
- Working with ACEs Aware grantees to review Core and Supplemental training curricula for Medi-Cal providers to ensure adherence to evidence-based research and clinical practice;
- Providing targeted technical assistance to ACEs Aware grantees to support provider engagement and communications efforts;
- Working with professional associations on development of learning collaboratives, trainings, and journal supplements;
- Working with external organizations and experts to lead and coordinate the development of clinical guidelines and white papers that incorporate an understanding of ACEs and toxic stress in the management of ACE-Associated Health Conditions; and
- Other work as identified by the ACEs Aware project team.



Responsibilities include but are not limited to:

1. Working closely with CA-OSG, DHCS, and other team members to accomplish the goals of the initiative.
2. Advising CA-OSG and DHCS on statewide implementation of ACE screening and clinical response and other clinical aspects of the ACES Aware initiative
3. Reviewing and providing feedback on ACES Aware Initiative work products to ensure adherence to the highest level of evidence- and research-based science and clinical practice as well as ensuring materials are relevant and useful for practicing clinicians.
4. Supporting the Clinical Implementation Subcommittee in developing work product and advising the ACES Aware initiative in coordination with CA-OSG, DHCS, and Aurrera Health Group.

Required Qualifications:

Must have:

- At least two to five years of experience in ACEs and toxic stress-related research and/or clinical implementation experience.
- Excellent oral and written communication skills.
- Skills related to effective project management, including strong work ethic, attention to detail, time management, ability to prioritize, problem solving, adaptability, willingness to learn, and a proactive work style.
- Medical degree and training/experience in ACEs and trauma informed care.
